Mr. Kretzmann stated that he would like to get an opinion from the Ethics Commission. Mr. Fox stated the he didn't feel he had a conflict and believes that the best thing for the District is to hire Mr. Carlisle. Mr. Fox stated that he would contact the Ethics Commission to get their opinion on this matter.

Mr. Hagy made a motion to hire Mr. Carlisle, seconded by Mr. Fox for discussion purposes only. Mr. Fox reiterated his support for Mr. Carlisle. Mr. Kretzmann stated that the Board would need to discuss the terms of an agreement.

Mr. Hagy amended his motion on Mr. Albers recommendation to hire Mr. Carlisle contingent upon an inquiry with the Ohio Ethics Commission and contingent up negotiation of the terms of employment. Seconded by Mr. Fox. Upon Roll Call vote, Mr. Kretzmann voted no, Mr. Hagy and Mr. Fox voted aye. Motion Carried
