Mr. Conkel stated we received 3 quotes. He stated he would like to go with GCI. They quoted \$51/hour with a minimum 2 hour charge for a site visit. The other two were \$53/hr and \$65/hr, both with a minimum 4 hour charge for a site visit.

PATASKALA UPDATE:

Mr. Conkel stated he met with Fannin & Deagle 8/28/17 and City of Pataskala reps last Friday 8/25/17, and things seem to be going well. He should know more in a couple of weeks. Mr. Fox stated the CIP was removed and should not be in the draft.

SUMMIT RD. WATER LINE PUBLIC MEETING:

Mr. Conkel stated there is a public meeting scheduled for September 7, at 7:00pm at Licking Heights High School. Door hangers were left on homes of all potential customers and information was put on our website. He has received some inquiries already regarding cost and if sewer would also be coming. After the meeting all questions/answers will be put on the website.

WTP CONSTRUCTION UPDATE:

Mr. Conkel stated the first progress meeting will be this Thursday, August 31 at 10:00am with the contractor and engineer. The site has been cleared and they have started hauling out soils at the clear well/ raw water storage area and started the berm between the Zellers Ln residents.

SUMMIT RD. TOWER CONSTRUCTION UPDATE:

Mr. Conkel stated the tower came down last Tuesday, August 22. They took it apart and were able to get it done in less than 1 day. They are now working on the foundation. Mr. Conkel stated there have been a few complaints from residents regarding the construction. He has apologized and explained it is temporary and necessary. The tank has to be up in a certain time frame to be able to paint. Mr. Conkel also stated he asked what it would cost to take down the Etna tank. If they can drop it down to the foundation it would be about \$8,500. If they have to take it apart it would be around \$23,000. Mr. Conkel will speak to property owners and see if that is a possibility.

WLDG MEETING:

Mr. Conkel stated the West Licking Development Group meeting is Friday Sept 1 at 9:00am. Mr. Fox will attend.

OPWC APPLICATION:

Mr. Conkel stated that the Ohio Public Works application is due right around October 1, 2017. We will submit application but we still have an existing OPWC project, the Taylor Rd. /Palmer Rd. water line project that has not been closed out. This is out of

our control as it is an ODOT project. Mr. Conkel stated he spoke with Sue Spiker with the county who said this Spring when they have planning committee meetings they will try to address the ODOT project issue.

WPCLF APPLICATION:

Mr. Conkel stated he will resubmit applications at the end of this week. These are the same applications we had last year.

PALMER/TAYLOR RD WATER & SEWER:

Mr. Conkel stated we just received approval to start hooking people up. We have 8 grinders at the WWTP ready to go.

MISCELLANEOUS:

Mr. Conkel stated he had a just cause for termination hearing last week with Jobs and Family Services regarding Rhonda Loomis. They were on the phone for over an hour and were not able to complete the hearing. It will be rescheduled to complete the remainder of hearing.

WWTP property was surveyed this week and there is a corral and other storage items on District property on the North property line. Mr. Conkel will contact owner give them 30-45 days to remove property.

8. OFFICE MANAGER'S REPORT

Mrs. Carrelli presented a copy of the water shut off list. She stated that there were 39 door tags distributed and as of today there were still 28 customers scheduled to have their water service disconnected tomorrow.

Mr. Carlisle asked if Palmer/Georgian Dr. paving was complete. Mr. Gilcher stated base is down and paving should be finished today. It is also supposed to be striped today. Total cost of \$18,000
