1. **OPENING**

2. ADOPTION OF AGENDA

Mr. Fox made a motion, second by Mr. Kretzmann, to approve the Agenda as presented. Upon Roll Call vote, all voted aye. Motion carried. Agenda adopted.

3. APPROVAL OF MINUTES

Mr. Kretzmann made a motion, second by Mr. Fox to approve the minutes of the Board meeting of September 26, 2017. Upon Roll Call vote, all voted aye. Motion carried.

4. PAYMENT OF BILLS

Mr. Carlisle moved to approve payment of the bills as presented. Mr. Kretzmann seconded. Upon Roll Call vote, all voted aye. Motion carried.

5. **COMMUNICATIONS**

Mr. Conkel stated that Mr. Wagner received a subpoena yesterday evening regarding 112 Humphries Drive. He stated that this was a contractor issue where the basement flooded. Mr. Conkel stated that the hearing will be held on Thursday, October 19, 2017. Mr. Carlisle inquired what Mr. Wagner would provide for the hearing. Mr. Conkel stated that Mr. Wagner was the inspector on the job and would provide inspection reports. Mr. Conkel stated that he will be out of town during that hearing, but will send our attorney with Mr. Wagner.

WATER TREATMENT PLANT CONSTRUCTION UPDATE:

Mr. Conkel stated that they have poured half of the clearwell floor. Mr. Conkel stated that the contractor should pour the other half on October 11, 2017.

SUMMIT TANK CONSTRUCTION UPDATE:

Mr. Conkel stated that the pedestal will be worked on this week.

RATE STUDY:

Mr. Conkel stated that he had discussion with Mr. Fox regarding incorporating Beechwood Trails into the District's regular rate structure verses the current flat rate billing. Mr. Conkel stated that he recommends if the Board is looking at potentially doing this, that prior to making any changes to Beechwood Trails the Board considers approving having an overall rate study done for the entire District. Mr. Conkel stated that he received two quotes regarding a rate study for the District. Mr. Fox stated that he is in favor of having the rate study done. Mr. Kretzmann stated that he is not in favor of having the rate study done. Mr. Carlisle stated that he is in favor of doing an in depth rate study prior to making any changes to Beechwood Trails. He stated that the study would answer some of the questions that the District has and would give them a more informed way of figuring out what the fairest overall restructure would be for all of the District's customers. Much discussion followed.

Mr. Fox made a motion, second by Mr. Carlisle, to proceed with a rate study by RCAP, not to exceed \$10,000.00, with Mr. Conkel working with RCAP on the time frame to have this done. Vote, Mr. Carlisle and Mr. Fox yes, Mr. Kretzmann no. Motion Carried.
